



**Great North Air Ambulance Service  
Advent Calendar Giveaway Terms & Conditions**

1. **Eligibility:** The Great North Air Ambulance Service Advent Calendar giveaway is open to legal residents of the United Kingdom and Isle of Man who sign up <https://www.greatnorthairambulance.co.uk/support-us/fundraising-events/advent-calendar/>. Entrants must be 18 years or older as of their date of entry in this promotion to qualify. This giveaway is subject to regulations and void where prohibited by law.
2. **Sponsorship:** The sponsor is the Great North Air Ambulance Service (“Sponsor”), located at Progress House, Urray Nook Road, Eaglescliffe, TS16 0QB. The Great North Air Ambulance Service will conduct the contest substantially as described in these Official Rules.
3. **Agreement to Rules:** By entering this contest, the Entrant (“You”) agrees to abide by the Sponsor's Official Rules and decisions, which are fully and unconditionally binding in all respects. The Sponsor reserve the right to refuse, withdraw, or disqualify any entry at any time at the Sponsor’s sole discretion. By entering this contest, You agree that You are eligible to participate based on eligibility requirements explained in the Official Rules. You also agree to accept the decisions of the Sponsor as final and binding as it relates to the content of this Advent Calendar contest.
4. **Great North Air Ambulance Service Advent Calendar Entry Period:** This promotion begins at 09:00 on 1 December 2024 and ends at 09:00 on 13 December 2024 (“Entry Period”). To be eligible for the giveaway, entries must be received within the specified Entry Period.
5. **How to Enter:** Eligible entrants can enter by submitting an entry via the online form provided. As a participant, your entry must fully meet all contest requirements, as specified in the Official Rules, in order to be eligible to win a prize. Incomplete entries or those that do not adhere to the Official Rules or specifications will be disqualified.
6. **Participants may only enter the draw once per day per email address.** Fraudulent methods of entry or circumvention of the rules will result in the Sponsor invalidating your entries and removing them from the contest.
